During the meeting it was emphasized that the Oversight Committee is responsible to contribute in effectively supervision of all programs financed by Global Fund and similar processes in Albania, in accordance with the delegated functions by CCM Albania for Global Fund, as defined in the CCM Governing Manual and Terms of Reference that the OS Committee must assists CCM to fulfill its responsibilities, to hold the Key Beneficiaries accountable towards given resources of GF and to get qualitative services, is required to put in place and maintain a transparent process, documented to supervise the program implementation. In this meeting it was discussed even the importance of visits; the tasks for providing all GF sub-recipients geographical spread of the main beneficiaries, the spread and services' types of service; the division of beneficiaries according to infections and priorities of marginalised groups.
